Opening	 Originally OEC decided closed RFP, continuation of funding Then decided to open it up if SRC wanted to vote If we decide to open up RFP, no additional funding- just new programs will have access to the available 13 slots we have available Any programs that join will need to follow current SR procedures. They would need to be NAYAC accredited Not guaranteed to be able to join in next year If we decide to open the RFP- we need to put out the public notice by April 1. To meet the timeline new programs need to e-mail interests by April 5. TA session required for new programs to review requirements All info needs to come back-non partisan readers to read applications and score them. Then, follow regular process for review at beginning of May. Decisions made at May meeting. All info in by May 23 to OEC.

Increasing the amount per space for next year- Kelly will share spreadsheet doc with the new funding decisions for programs No more changes can be made after May 1 We are currently at 92% utilization- we previously were at 72% Of the 13 slots not used- causes amongst programs are-

- Total of 8 infant and toddler- this means a total of 2 or 3 preschool slots are used for this

- PLEASE REMEMBER TO FILL OUT THE LIVE DOCUMENT TO KEEP SLOT AVAILABILITY UP TO DATE. KELLY SHARED THE DOCUMENT BY E-MAIL AND IN THE MEETING CHAT.
- The reason the timeline is so tight is to allow time to make changes for funds by July 1
- Slots, with the exception of Mitchell, are full day/full year slots
- We can wait for answers to our questions from OEC, and vote can be put out digitally
- Superintendent Ritchie brought up a creative idea to consider allowing programs to utilize their slots at a different location.
- Question about if there are known programs within the community would be interested in applying. Currently one SRC member is aware of one center in Waterford who is interested.
- A Google form will be sent for voting once our questions are answered.
- Concerns about the vote being confidential. It is against our bylaws as a council.
- If a program applies- the slots could be converted to infant toddler
- LEARN is building a new birth to eight school. The school is several years out so Adrenna believes they would not be eligible for application at this time.
